Forced linear equations

- [1] Superposition II
- [2] Harmonic sinusoidal response

I drew the spring/mass/dashpot system and added a force to it: the little sail comes back into play.

$$mx" + bx' + kx = F_ext$$
 (*)

Notice by the way that I can put the damper on the left in parallel with the spring: it still opposes velocity. If x' < 0, F_dash > 0 and so on: so you get exactly the same equation.

Also important will be the "associated homogeneous equation"

$$mx'' + bx' + kx = 0$$
 (*) h

which we know all about after Lecture 12. Final comment on this: We can "reduce" this by dividing by m:

$$x'' + (b/m)x' + (k/m) = 0$$

If b=0 we get solutions with circular frequency sqrt(k/m). If b>0, you get exponentially damped sinusoids, with smaller circular frequency omega_d (or not oscillating at all, if b is big enough). In general, even if b>0, we call sqrt(k/m) the "natural circular frequency" of the system, and write omega_n for it. So in the underdamped case, when there is an omega_d , omega_d < omega_n . So the reduced homogeneous equation is $x'' + (b/m) x' + omega_n^2 = 0$.

[1] The general strategy in finding solutions is based on "superposition."

[Slide:]

Superposition I: If x1 and x2 are solutions of a homogeneous linear equation, then so is any linear combination c1 x1 + c2 x2 . If the equation is of second order and neither of x1 , x2 is a multiple of the other, then c1 x1 + c2 x2 is the general solution.

Now we have:

Superposition II: If xp is any solution to (*) and xh is a solution to $(*)_h$, then xp + xh is again a solution to (*).

Proof: Plug x into (*):

- k] x = xp + xh
- b] x' = xp' + xh'
- m] x" = xp" + xh"

$$mx" + bx' + kx = (m xp" + b xp' + k xp) + (m xh" + b xh' + k xh)$$

= $F_{ext} + 0$

as we wanted.

In fact, if xh is the general solution to $(*)_h$ then xp + xh is the general solution to (*).

This proof works for linear equations of any order; for example first order, where we already saw it as a consequence of the method of integrating factors.

Superposition II splits the problem of finding the general solution to (*) into two parts:

- (1) find SOME solution to (*), a "particular solution," and then
- (2) find the general solution of (*)_h .


We have just been studying solutions too (*)_h, so let's focus on finding a particular solution.

[2] First case: b = 0 , sinusoidal driving term.

The model is the weight on the rubber band. I showed its natural frequency, and then drove it by moving my hand sinusoidally, first slowly and then faster. At first the mass just follows the motion of my hand, but as the frequency picks up the rubber band starts to stretch at the lows and compress at the highs. At a certain point things get really wild, but then settle down - but now the mass is moving UP when my hand goes down, and vice versa.

Can we explain all that mathematically?

I drew a spring/mass system, forced through the spring:



Set up the parameters x and y so that when x = y the spring is relaxed. So when x > y the spring is stretched and the spring force is negative:

$$m x'' = k(y - x)$$

or
$$mx" + kx = ky$$

Think of y as the input signal - the position of my hand - and x as the system response or output signal.

So in the sinusoidal case, set the clock so that the input signal has the

$$y = A \cos(omega t)$$

So:
$$x'' + omega_n^2 x = A omega_n^2 cos(omega t)$$
 (**)

There are two frequencies here: the natural frequency omega_n of the system and the frequency omega of the input signal A cos (omega t).

The experiment with the weight and rubber and encourages us to use the Method of Optimism, and hope for a solution of the form

```
xp = B cos(omega t)
```

To see what B must be, plug this into (**):

omega_n^2]
$$xp = B \cos(\text{omega t})$$
1]
$$xp" = -B \text{ omega^2 } \cos(\text{omega t})$$

A omega_n^2 $cos(omega t) = B(omega_n^2 - omega^2) cos(omega t)$

This works out if we take

```
B = (omega_n^2 / (omega_n^2 - omega^2)) A
```

The output amplitude is a multiple of the input amplitude, and the ratio is the GAIN:

```
H(omega) = |B/A| = omega_n^2 / |omega_n^2 - omega^2|
```

Imagine the natural frequency of the oscillator fixed, and we slowly increase the frequency of the input signal. The graph of the gain starts when omega = 0 at H=1 - consistent with what we saw - and then increases to a vertical asymptote at omega = omega_n . This is RESONANCE, and then no such sinusoidal solution exists. There are solutions, of course, and we will come back to this case later. What happens with the weight and rubber band is that the nonlinear character of the spring asserts itself for large amplitude.

When omega > omega_n , the gain falls back towards zero.

Also: when omega < omega_n the denominator is positive, and the output is a positive multiple of the input. When omega > omega_n the denominator is negative, and the output signal is a negative multiple of the input: this is PHASE REVERSAL.

We have nicely accounted for all the things we observed. I demonstrated this effect using the Mathlet Harmonic Frequency Response: Variable Input Frequency.

[3] Exponential signals

$$mx'' + bx' + kx = A e^{rt}$$
 (*)

We want to find some solution, x_p . Again as in the first order case,

try for a solution of the form $x_p = B e^{r}$:

$$k] x_p = B e^{rt}$$

b]
$$x_p' = B r e^{rt}$$

$$m] x_p" = B r^2 e^{rt}$$

$$A e^{rt} = B (mr^2 + br + k) e^{rt} = B p(r) e^{rt}$$

We saw the same thing in the first order case. It's a general fact about linear constant coefficient equations with exponential right hand side:

$$a_n x^n + ... + a_1 x' + a_0 x = A e^{rt}$$
 (*)

with characteristic polynomial $p(s) = a_n s^n + ... + a_1 s + a_0$:

Exponential Response Formula: A (particular) solution to (*) is given by:

$$x_p = A e^{rt} / p(r)$$

as long as p(r) is not zero.

- i.e., if r is *not* a root of the characteristic polynomial. If p(r) = 0, the system is "in resonance" with the input signal, and there is no solution of the form B e^{rt}.

Eg
$$x'' + x' + 2x = 4 e^{3t}$$
 $p(3) = 3^2 + 3 + 2 = 14$ so $x_p = (4 / 14) e^{3t}$.

[4] Now let's try this: x'' + x' + 2x = cos(t)

by *complex replacement*: This is the real part of

$$z'' + z' + 2z = e^{it}$$

 $p(s) = s^2 + s + 2$, $p(i) = (i)^2 + i + 2 = 1 + i$,

$$z_p = (1/(1+i)) e^{it}$$

We want the real part.

$$z_p = ((1-i)/2) (\cos(t) + i \sin(t))$$

$$x_p = (1/2) (\cos(t) + \sin(t))$$

To understand this, sketch the triangle: sides 1/2 and 1/2 so hypotenuse A = sqrt(2)/2 and angle phi = pi/4:

$$x_p = (sqrt(2)/2) cos(t - pi/4)$$
.

Lesson: the damping term, b, creates a nonzero imaginary part in the denominator of the ERF, and that causes phase lag in the solution. It also causes the magnitude of the denominator to increase, and hence the amplitude of the sinusoidal solution to decrease.
